




The City of New Port Richey Fire Department has announced Captain Keith Bauer as the 2020 Firefighter of the Year recipient.

A NEW FIRE STATION

The City Council recently approved the construction of a Fire Station to replace Fire Station #2. The current station is a 46-year-old, one -bay station

located in a residential area at 6141 High Street. The City has considered replacing this station for many years due to the size, location and condition of the building. The new Fire Station #2 will be constructed on the northeast corner of Grand Boulevard and Marine Parkway. The City is currently working with Spring Engineering, Inc. on the programming and design phase of the project with an emphasis on health and safety considerations.

The new station will be a 8,700 square foot, one-story building with two drivethrough bays for fire apparatus. The station will offer many modern design features including a hot, warm and cool zone interior layout that provides a safe working environment for the firefighters. This layout has become an industry standard due to the alarming increase of firefighters diagnosed with cancer caused by job-related exposure to carcinogens.

Some of the features incorporated in the station hot zone include a decontamination room with a shower and an extractor to wash gear, bunker gear storage room, and a diesel exhaust system in the apparatus bays. The warm and cool zones will include a public accessible lobby area, station office, training room, kitchen and dining area, living area, fitness room, District Chief office and individual bunk rooms.

The location of the new Fire Station #2 allows for easy access to the busy U.S. Highway 19 corridor, which will greatly improve response times. The location will also allow the Fire Department to maintain an impressive four-minute response time to the entire Fire Station #2 service area. The Fire Department looks forward to being good neighbors in the Marine Parkway district.



Walking through downtown New Port Richey is drastically different today that it was five years ago. Renovations to public spaces, new businesses adorning Main Street, and the swell of popularity from visitors and residents alike have contributed to the new vibe in the City. Anticipating the likelihood to become West Pasco County's de facto downtown, The City and the Community

Redevelopment Agency (CRA) launched Stage 1 of the City's Master Plan by enlisting consultants Arnett Muldrow & Associates to develop a brand platform. A brand platform is a foundation for an organization's identity, messaging and visual presentation. The goal of the new brand was to capture the City's positive momentum and to standardize the

city's internal and external communications in order to promote the brand. Extensive research was conducted to collect stakeholder feedback before translating the community's strengths into a graphic brand platform. At a CRA meeting the Board of Directors voted unanimously to implement the final product: a citywide logo with extensions for each department, a color palette, a branded typeface, and a strategy for marketing and implementation.

They also voted to move forward on the final stages of the Master Plan, which will focus on proposing concepts to further develop the US HWY-19 corridor and the downtown district. The ultimate result will be a vision of what New Port Richey could look like through the thoughtful consideration and support of the business community and the continued advancement of the city's CRA.

The candidate qualifying period begins at noon on Tuesday, February 9, 2021, and runs until noon on Tuesday, February 16, 2021. Residents who wish to vote by absentee ballot may do so from Monday. March 8, 2021, through Monday, April 12, 2021, between 8 am and 5pm, Monday through Friday, at the City Clerk's Office, Second Floor, City Hall, 5919 Main Street. Voters must reside within the corporate limits of New Port Richey, and must bring proof of residency. All voting on Election Day shall take place from 7 am to 7 pm at the New Port Richey Recreation and Aquatic Center, 6630 Van Buren Street.

As Florida's population continues to grow, it takes all of us to protect the state's water supply and ensure our communities, wildlife, industry, and agriculture continue to flourish.

The City of New Port Richey protects Reclaimed water has been recycled, in our region's water supply by employing various strategies to reduce unnecessary water usage. Residents and utility customers can help our community lead the way to responsible water stewardship grass growth. by taking advantage of these three water conservation opportunities.

Rebate Program

The City partnered with four other local government agencies along with Tampa Bay Water and SWFWMD to save water in the Tampa Bay Region. The water conservation program - Tampa Bay Water Wise - offers rebates to residents and commercial property owners who take proactive steps to reduce water use and demand on the region's water supply. Residential property owners can qualify for rebates ranging from \$100.00 for toilet replacements up to \$250.00 for smart irrigation controllers.

Reclaimed Water

Reclaimed water is the final product of a multiple-stage advanced treatment that can be safely used for irrigation and other non-potable (other than drinking) uses. Using it helps reduce demands on our groundwater use by providing an additional water source for our growing community.

To use reclaimed water for lawn watering, you can connect your current irrigation system with little or no modifications. The \$300.00 installation/connection fee includes \$150.00 for a 3/4" meter and \$150.00 for the Backflow Prevention Assembly installation and test. Pay once, or use a convenient monthly payment option for 1 or 2 years.

Keep Savings Flowing with a Water-Saving Conservation Kit

The City is pleased to offer indoor and outdoor conservation kits to utility customers. Take advantage of water, energy and money savings by using the kit's tools to reduce water waste in your home. Kits are available at the Billing and Collections Division of the Finance Department, located in City Hall. The indoor kit includes an earth showerhead, toilet flapper, leak detection dve tables, and a bathroom sink faucet aerator, while the outdoor kit includes a moisture meter, rain gauge, water wheel, and a seven-spray hose nozzle.



Go Green! E-billing is a convenient and environmentally-friendly way to receive, review, and pay your monthly utility bill from any desktop, tablet or phone. It **allows customers** to receive utility statements by email instead of through regular postal mail. By going green, you'll receive your statements quicker, so you have more time to pay. The City of New Port Richey's boards and committees perform a vital role in improving the quality of life in our community. There are currently openings on several boards and committees for those who want to take an active role in making a difference in our city.

- The Cultural Affairs Committee takes part in the creation of cultural activities for the education and recreation of our residents. The committee also reviews all requests made to the City for co-sponsorship of cultural events.
- O The Environmental Committee serves as the planning committee for the City's environmental and recycling events in addition to advising the City Council on environmental initiatives. The committee serves as the planning committee for the City's major environmental events.
- The Historic Preservation Board is chartered with the power, authority and jurisdiction to regulate and administer historical, archaeological and architectural resources and to recommend resources for historic designation to the City Council. Members of the Board shall preferably have knowledge of architecture, history, and/or the historical or architectural development of the City, or at minimum, have a deep concern for historic preservation, development and enhancement of the City's historical resources.
- The Land Development Review Board offers advisory recommendations on matters involving the development of land. The Board also makes recommendations to the City Council regarding ordinances which amend the City's Comprehensive Plan and Land Development Code. The Board serves as the City's Local Planning Agency per the requirements outlined in the Florida Statutes.
- The Library Advisory Board makes recommendations to the Library Director and the City Council concerning matters pertaining to the use of the library. The Board aids in the library's long-range planning and assists the Library Director in preparing policies and procedures.
- The Parks and Recreation Board plans, promotes and assists the city's Parks and Recreation Department on recreational projects and events. The Board also works with other local agencies on events held throughout the year in city parks.
- The Firefighters' and Police Pension Boards determine the amount of all retirement allowances or other benefits for their respective groups. The Boards also reviews and processes all applications for benefits.

To be eligible to serve on a city board or committee, with the exception of the Library Advisory Board and Historic Preservation Board which have their own specific requirements, you must be a registered voter and reside within the city limits. If you are interested in applying for a volunteer position, applications are available on the City's website at www.cityofnewportrichey.org/city-departments/ boards-committees
