Properly identified and delivered prior to the deadline to the City Clerk's Office. The company name and full address of the proposer shall be clearly shown on the outside of the sealed envelope with the designation "RFQ23-021 GENERAL UTILITY ENGINEERING, WATER-RESOURCES & ENVIRONMENTAL CONTINUING SERVICES."

The successful proposer(s) shall prove by qualifications, experience, availability, approach and plan for the work that will best serve the overall needs of the City of New Port Richey. The selection of the successful respondent(s) shall be at the City's discretion and shall be made in a prompt manner after receipt and evaluation of all responses.
