Final Plat shall be in Compliance with Florida Statutes Chapter 177, Section 1, Part 1 and Section 9.06.00 of the New Port Richey Land Development Code.

The final plat must be drawn at a scale not smaller than 1 inch = 100 feet. The sheet size shall conform to current requirements of Pasco County plat books. If more than 2 sheets are required, include an index sheet of the same dimensions that show the entire
subdivision on 1 sheet.
If deed restrictions are imposed on the subdivision, they must be included on the final plat.
The final plat must be submitted electronically.
The final plat must include:

- 1. The name under which the subdivision is to be recorded and the number of the section, township and range.
- 2. Written acknowledgement of the property owner to the plat and restrictions including dedication to the public use of all streets, alleys, parks, and open spaces and the granting or dedicating of easements;
- 3. Boundary lines of the area being subdivided with accurate bearings and distances;
- 4. Correct detailed legal description
- 5. Exact layout showing:
 - a. All dimensions, both linear and angular, for locating lots, streets, sidewalks, alleys, public easements and private easements.
 - b. Street names with the provision that the name of no new street shall duplicate the name of any existing or platted street unless the new street is a continuation of an existing or platted street;
 - c. Lots numbered in numerical order and appropriately identified;
 - d. The location of all building lines and easements provided for public use, service or utilities;
 - e. The lines of adjoining streets and alleys with their width and names;
 - f. The accurate outline of any portions of the property intended to be dedicated for public use or for common use of property owners within the subdivisions;
 - g. The locations of all permanent reference monuments together with their character or description; permanent reference monuments shall be located at each block corner, point of curve, and on each exterior corner of the subdivision;
 - h. Scale of the plat, north arrow and date;
 - i. Private restrictions and trusteeships and their periods of existence.
 - j. The certificate of the surveyor attesting to the accuracy of the survey and that permanent reference monuments have been established according to the provisions of this chapter;
 - k. All excepted parcels by appropriate designation;
 - l. Certificates for approval and signature panel for the mayor and city clerk and the county commissioners.
